### Overview

Social auditors play an essential role in maintaining the integrity to ensure human rights in workplaces around the world.

This course reviews fundamental concepts and highlights from SAI's Basic Auditor classroom course. It is a pre-requisite to SAI's Advanced Auditor classroom course. The goal is to promote a stimulating, value-added learning environment - where all participants enter the Advanced Auditor classroom well-prepared and ready to engage with trainers and peers in the advanced exercises and discussions. The course can also be taken as a standalone, for those seeking a primer or refresher on key aspects of management-systems based auditing for labor standards.

Additionally, the course reinforces and develops advanced knowledge, skills, and attitudes for experienced social auditors. The class builds on the collective experiences of the participants, offering insight into fundamental issues that arise on a regular basis in field assessments.
